**Notice of Open Season to Sell Unsubscribed Firm Transportation Capacity:** Per Section 8.14 of the GT&C, Southern Star is accepting binding bids for the available unsubscribed firm transportation as described below.

- 1) This service can commence as early as gas day February 1, 2020 to April 1, 2020.
- 2) Bids must be submitted from January 29, 2020 9:00 A.M. CCT until January 30, 2020 3:00 P.M. CCT (the "Bid Period"). All bids/service requests for this capacity submitted during the Bid Period will be treated as being received at the same time.
- 3) Conditional bids will be considered non-conforming bids. Southern Star may reject any non-conforming bids or bids that do not otherwise satisfy the terms of the open season.
- 4) Shippers must satisfy the requirements of GT&C <u>Section 8.5 Credit Worthiness</u>. In addition to the DUNS and EIN information, additional credit information or evidence of creditworthiness may be requested.
- 5) Bidding Process:
  - a) Shippers desiring to bid on such capacity must complete a valid <u>Service Request Bid Form</u> online and then submit via email to <u>SSCContractAdministration@southernstar.com</u> or fax to (270) 852-5020.
  - b) For questions concerning bidding procedures or this open season, please contact your Customer Service Representative. Answers to general question(s) that are not related to a specific shipper request will be posted under the FAQ section.
- 6) Bid Evaluation:
  - a) Bidders may bid at Southern Star's FERC-approved Maximum Recourse Rates, or at another rate, which may be less than, equal to, or greater than the Maximum Recourse Rates, and which shall be deemed a Discounted or Negotiated Rate, as appropriate, pursuant to Southern Star's FERC Gas Tariff. Per GT&C Section 8.14, Southern Star reserves the right not to award capacity at less than the applicable maximum rate.
  - b) The bid or combination of bids which provide the highest net present value will be awarded. Any bid requesting to move or change Primary Points under GT&C Section 4.2 will be considered to have a net present value of zero when comparing requests for service and awarding capacity, unless Shipper has agreed in conjunction with its request to increase its Maximum Daily Transportation Quantity (MDTQ) or to extend the term of its firm contract(s), in which case Southern Star may consider the terms of such MDTQ increase or such mutually agreed contract extension when evaluating the net present value.
  - c) In the event of a tie or ties, the capacity will be awarded (pro rata) among the winning bidders who elected to accept a partial award. Any remaining capacity will be awarded (pro rata) to the next highest ranked bidder(s).
- 7) Award Process: Bids will be awarded within five business days after the end of the Bid Period.
  - a) Southern Star will advise the successful bidder(s) of the award.
  - b) After being advised of having made a successful bid, a bidder must:
    - i) Satisfy the conditions set forth in Item 4 above;
    - ii) Execute a Firm Service Agreement with Southern Star.

If a successful bidder does not satisfy all of the above requirements after receiving notice of a successful bid, the award will be cancelled and the capacity will be awarded first to any equally ranked bidder(s), if any, who received a pro rata allocated capacity award pursuant to Item 6c, and then to the next highest conforming bidder(s).

8) Disclosure of Successful Bid(s): Southern Star shall post the identity of the successful bidder(s) within five business days of the award.
