Dear Ms. Bose:

Pursuant to Section 10.3 of the General Terms and Conditions ("GT&C") of its FERC Gas Tariff, Southern Star Central Gas Pipeline, Inc. ("Southern Star") submits herewith for filing its report of penalty revenue collected during the periods in which an Operational Flow Order ("OFO") occurred within the past twelve months ending September 30, 2018, and the corresponding refund plan, if necessary.

## Statement of Nature, Reasons and Basis

OFOs are issued on the Southern Star system pursuant to GT&C Section 10 and are used to prevent or alleviate operational conditions that may threaten the integrity of all or portions of the pipeline system. Southern Star did not issue any OFOs during the twelve-month reporting period from October 1, 2017 through September 30, 2018. Therefore, no penalties were assessed or collected during the twelve-month period and result in no penalty revenues or associated refunds.

## Commission Action and Waivers Requested

In its Letter Order Pursuant to § 375.307 issued August 30, 2012 in Docket No. RP12-181-000, the Commission accepted, for informational purposes, Southern Star's annual OFO report for the twelvementh period ending September 30, 2011. In that letter order Southern Star was "advised that [future] OFO reports, if not protested, will be treated as informational and the Commission may not issue an order on those reports." Consistent with that advice, Southern Star will consider this OFO report to be accepted for informational purposes if no timely protests are filed. Otherwise, Southern Star respectfully requests that the Commission grant any waivers as it may deem necessary for the acceptance of this filing.
