

Request for Offers to Sell Gas

Southern Star Central Gas Pipeline, Inc. (“Southern Star”) desires to purchase approximately 50,000 Dth of natural gas between May 2022 and October 2022 for its own system use. Southern Star invites interested parties (“Sellers”) to submit binding bids (offers to sell gas) during the term of this posting as defined below.

Bidding Period

Bidding will begin at 1:00 p.m., CCT, Thursday, March 24, 2022, and will expire at 3:00 p.m., CCT, Thursday, March 31, 2022. Potential Sellers should email the bids to “SSCContractAdministration@southernstar.com.” Bidders should also have a master NAESB Base Contract for Sale and Purchase of Natural Gas (see <http://www.naesb.org/wgq/cont.asp>) established with Southern Star prior to bidding.

Submission of Bids

Potential Sellers should submit an offer to sell by emailing SSCContractAdministration@southernstar.com that includes the following information:

1. Term: Southern Star requests that each bid includes a term that begins on or after May 1, 2022 and ends on or before gas day October 31, 2022.
2. Desired Receipt Point (including pooling points)
3. Total Quantity (Dth)
4. Fixed Price

Award of Bid(s)

Upon conclusion of the bidding period, Southern Star will evaluate bids and will determine the best bid, or best combination of bids, resulting in the least cost to Southern Star. Southern Star may award, and offer to purchase, only a portion of the quantity offered in a bid depending on the total number of bids received and their value. In the event of duplicate bids, Southern Star will extend the bid term in order to allow those parties to submit another bid. Southern Star reserves the right to accept or reject any or all bids that are economically unacceptable to Southern Star in its sole discretion or that contain conditions, including but not limited to desired receipt point(s), unacceptable to Southern Star in its sole discretion.

Southern Star will notify the winning bidder(s) by 4:30 pm CCT, on Friday, April 1, 2022, of the best bid(s) determination including the results of said allocation of its purchase quantity. After “best bid(s)” determination by Southern Star, the successful Seller(s) and Southern Star will execute a written NAESB gas purchase Transaction Confirmation to facilitate completion and verification of the transaction.
