Capacity Release Overview

1.0 Overview

- ◆ Capacity Release - The temporary or permanent reassignment of a shipper's capacity, in whole or in part, under Rate Schedules TSS (Trans-Storage Service), FTS (Firm Transportation Service), FSS (Firm Storage Service), and FS1 (Firm Storage Service with Market Based Rates) as provided in Southern Star's Tariff Section 11 of General Terms and Conditions within the term of the shipper's underlying Service Agreement.
- ◆ Open access pipelines are required by 18 CFR §284.8 to offer the release of firm capacity as part of their open access tariff.
- ◆ Capacity releases are accomplished using standards approved by NAESB, adopted by FERC per 18 CFR §284.12, and incorporated by Southern Star.

Access and Security

2.0 Access & Security

- ◆ To place offers and bids for capacity on Southern Star's CSI website, users are required to have a login and password with capacity release rights in order to access the Customer Activities area of our website which contains the Capacity Release Menu.
- ◆ Access can be requested electronically by completing the CSI Access Form found under the Informational Postings area of Southern Star's CSI website under Electronic Forms.

3.0 How to set up a Capacity Release Offer

Offers

To create an offer for released capacity: Under Capacity Release/Offers, choose the Create button in the top right corner.

A. OFFER INFO – All Mandatory items will be highlighted in red.

- a. Under **Releaser Information**, Choose Releaser Prop Name and Rel Contact.

Under **Contract Information**, use the dropdown arrow to see a list of all firm contracts. (Only contracts that are able to be released will populate). Choose the contract from which capacity is to be released. The system will automatically populate the information specific to the selected contract. **NOTE:** The Rate Sch (Replacement) field will default automatically except when the release is from a TSS. Choose the replacement rate schedule type of FTS, FSS or TSS as well as the Location Zone, depending on the nature of the release.

- b. Enter the Rel St Date, Rel End Date. (The Rel End Date should be a “to date”. For example, a Rel End Date of 10/1/2019 would result in a release including gas day 9/30/2019 but not including 10/1/2019).
- c. For the Perm Rel Desc, & All Re-Rel use the dropdown arrow to choose the appropriate description from the list.

- d. Under **Pre-Arranged Customer Information**, use the dropdown arrow to choose the appropriate description from the list. **If the release is pre-arranged:** Choose a dropdown under Affiliate Indicator & Bidder Data to identify your bidder. **If the release is not pre-arranged:** No other fields will be required.

e. **Bid Information:** Choose from the dropdown for the Bid Deal Desc: biddable or non-biddable. If biddable is chosen, addition fields will show up requiring information specific to the parameters of the bid. The Repl SR Role Ind must be filled out via the dropdown options. Bid Eval Ind Desc, Bid Eval, Bid T-brk, & Shorter Term will populate based on previous criteria. Bid Per St Date /Time will default to the current date. You may choose future dates as long as they follow the NAESB bid period requirements. The Prearr Match Date/Time and Bid Per End Time & Cap Awd Date will default automatically to the correct dates and times. The Rel Req Post Date/Time will default to current date and time once the offer is submitted. You may, however, enter your own NAESB required timeframes. You can save the offer at this point by clicking the “Save Offer” button in the top right corner of the screen.

Once all information has been completed, choose the **RATE** tab from the top menu ribbon to proceed to the next section.

- B. RATE:** The top portion will Auto populate with the applicable information.
- a. Use the dropdown arrow to choose the appropriate Rate Form/Type Desc:
 - b. Use the dropdown arrow to choose the appropriate Rel Acpt Bid Basis Desc.
 - c. The Mkt Based Rate Ind. And IBR Ind will automatically default to the appropriate information.
 - d. Use the dropdown arrow to choose the appropriate Min Rate Discl Des. if applicable.
 - e. The Surchg Ind Desc, Res Rate Basis Desc and Meas Basis Desc fields will automatically default to the correct information
 - f. Disc Ind field will default to “No Discount” if a discount does not exist. If a discount does exist, choose the appropriate option from the dropdown.
 - g. After completing the above fields, the Standard Rate fields will appear. Enter the appropriate information under the rate fields. Depending on the type of release, there may be more than one field to complete.

In the example below, it is a biddable pre-arranged deal, so a Min Acpt Rate and Rate Bid are required.

e. Once all information has been completed, choose the next tab from the top menu ribbon (Quantity/Location). You can also Save Offer at this point.

**If there are errors, you will see a list of all errors in a pop-up, an indicator on each tab where the error is occurring, and the field with errors will be Red.

C. QUANTITY/LOCATION

- The Avail Qty – K field will be automatically populated with the quantity available for release for the chosen contract. The Cycle field will default to the appropriate cycle depending on the dates chosen on the Offer Info page.
- Enter the appropriate quantity in the Max Offer Qty – K field.
- Use the dropdown arrow beside Rel Sr Less Qty to choose the appropriate information. If “Y” is chosen, complete the appropriate information for the Min Offer Qty K field and (if prearranged) the Bid Qty –K field.
- Choose the appropriate information for the RAPP Desc field by using the dropdown arrow.

- e. Once all of the above information is completed, the Locations screen will appear. Enter the appropriate information related to the quantities by location under all fields required. In the example below, it is a prearranged, biddable deal with the agreement of the releasing party to accept a lesser volume. Therefore, a Max, Min and Bid Qty are required.

- f. Once all information has been completed, you can choose the Save Offer button to save the offer for future submission or you can proceed to the next tab (Terms) from the top menu ribbon. Again, if there are errors, you will see a list of all errors in a pop-up, an indicator on each tab where the error is occurring, and the field with errors will be Red.

D. TERMS

- a. Use the dropdown arrow to choose the appropriate information for the Rel Sr Contng field. If "Y" is chosen, the Contingency End Date/Time fields as well as the Releasing Shipper's Contingency Terms field will appear. Choose or enter the appropriate information for those fields.

- b. Under Recall/Reput Desc, use the dropdown arrow to choose the appropriate information. If any form of recallable is chosen, the Recall/Reput Terms field will appear as well as the Business Day and Cycle Indicator fields. Choose or enter the appropriate information for those fields. Option to use the dropdown arrow in the “All” field to choose Y or N to auto-populate all the following fields, Business Day Indicator, Recall notif Timely, Recall notif EE, Recall Notif EVE, Recall notif ID1, Recall Notif ID2, Recall Notif ID3.
- c. For the Stand-alone offer field. If “N” is chosen, the Not a Stand Alone Offer terms fields will appear. Choose or enter the appropriate information.
- d. If there are any Special Terms, Indemnification Clauses or if the agreement has an AMA relationship, complete the related fields with the appropriate information.
- e. Once all the above information is complete, choose the “Save Offer” button to save the offer for future submission or the “Submit Offer” button to submit immediately. If there are errors, a list of all errors will appear, and an indicator on each tab will show where the error is occurring. The field(s) with errors will display in red. Correct the error(s) and choose the Submit button again.

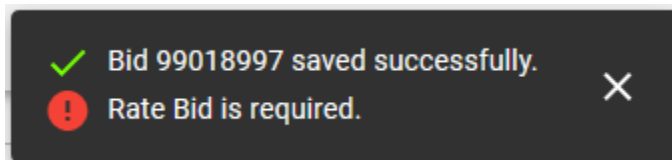

- b. The terms page will include all terms related to this offer including the recall/reput terms and other special terms. The Stand-alone Bid Desc is the only field requiring completion. If you choose “Not a stand-alone”, Bid Terms and Conditions will appear. Select the dropdown arrow and choose the correct option for the bid. Once all information is complete, choose the Save Bid button to save the bid for future submission or choose the Submit Bid button to submit your bid. If there are errors on any page, a message will be display on the top of the screen in red. Correct the error and choose Submit Bid again. If successfully submitted, the Bid number will appear at the top of the screen with the bid #.
- c. Pre-arranged non-biddable deals will be awarded instantly. Biddable deals will be awarded on the bid end date at 1:00pm.

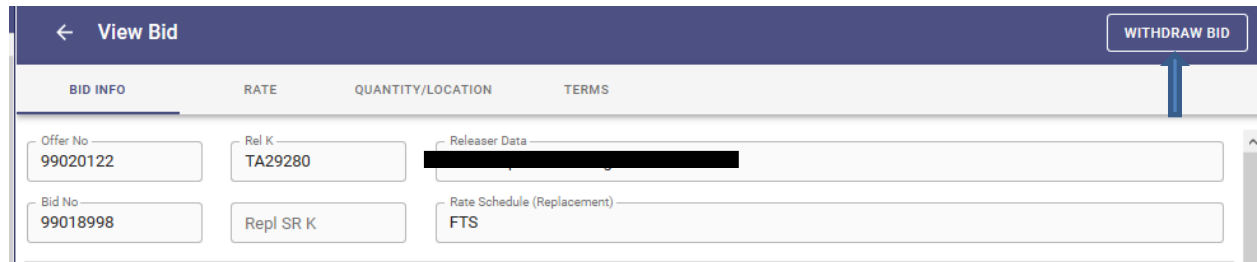

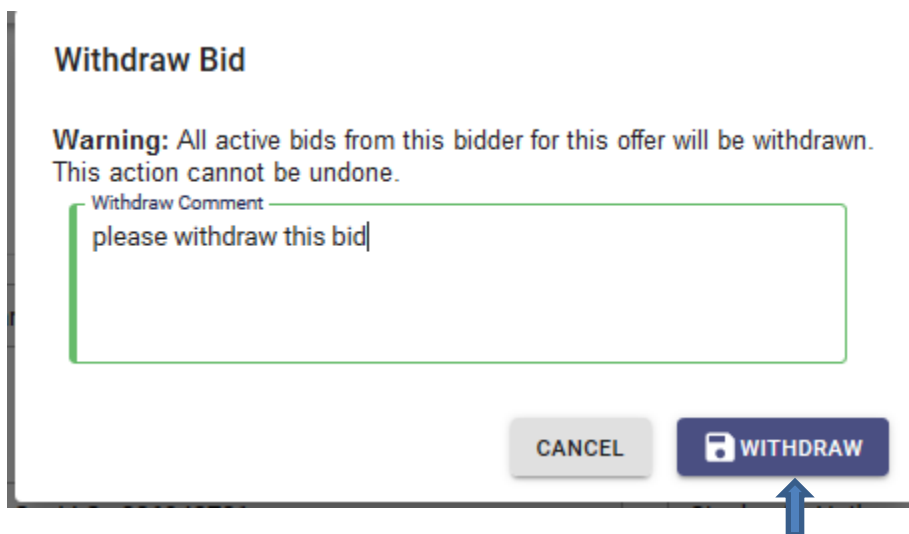
